The Show Site will be available to exhibitors at approximately 7:00 am Saturday, August 2, 2008 Dogs must be removed from the building immediately following end of judging each day.

Please ***USE*** the designated exercise area, and **YOU CLEAN UP FOR YOUR DOG!** Pooper Scoopers and containers are furnished. Kindly cooperate so we have the chance to use this property in the future. Please maintain your crating area, and **LEAVE IT CLEAN.** Please **CLEAN UP SPILLED DRINKS OR WATER.** Dogs are **NOT** allowed in the building overnight. All dogs must be on leash while not in the ring. Please respect these requirements.

NEITHER THE DEEP SOUTH ALL BREED OBEDIENCE TRAINING CLUB, INC., the Trial Secretary, nor any Trial Official will assume responsibility for any loss, theft, damage or injury sustained by an exhibitor, handler, or any of their dogs or property and further assumes no responsibility for injury to children. **DOGS MUST BE READY FOR JUDGING.** Judges are not required to wait for any dog.

The Club reserves the right to substitute a prize of equal or greater value. All trophies must be claimed the day of the show. None will be mailed. Exhibitors must remain for presentation if eligible for Special Prizes or they will forfeit such prizes. If not claimed the prizes will become property of the club.

“WILD CARD” OBEDIENCE CLASSES:

“Wild Card Novice,” “Wild Card Open,” & “Wild Card Utility” are open to any AKC –eligible dog. They are the same as the regular “A” classes, except that ONE exercise may be skipped. You may talk to your dog and offer encouragement, as in Rally. Second commands on a principle part of an exercise, however, will be penalized. The distinction between “encouragement” and a “second command” is in the judge’s discretion.

NON-REGULAR RALLY CLASSES:

*“Rally Pairs Class”: (one handler, two dogs). This class consists of competition by handlers working two dogs at one time through a rally course at a level selected and offered by the event-giving club. Scores will be based on a possible 200 points, with ties being broken by time. Clubs may offer all rally classes levels, **Rally Novice, Rally Advanced, & Rally Excellent**, excluding jumps. (See Rally Regulations for scoring).*

DIRECTIONS TO SHOW

FROM WEST: Take I-10 and exit at Williams Blvd (Exit 223A-B), turn North. Get in Right lane. Turn Right onto Bruin Dr. Continue on this street until you see Bonnabel High School on your right. Look for the driveway with the dog show sign follow this drive around to the back where the Gym is located.

FROM EAST: Take I-10 and exit at Power Blvd. (Exit 224), go right (North). Get in Left lane. Take first U-Turn (Red Light before Kawanee), get in Right lane. Turn Right onto Bruin Dr. Look for Bonnabel High School on your left. Look for driveway with the dog show sign follow this drive around to the back where the Gym is located.

Refunded checks do not constitute a valid entry and a collection fee will be added to the amount of each returned check. Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian, or judge or barred from competition by action of the Show Committee. No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes, or any other causes beyond the control of the Club, or the Trial Secretary.

ENTRIES CLOSE AT 6:00 P.M. CST, Wednesday, July 16, 2008.

ENTRY FEES FOR BITCHES COMING IN SEASON after entries close will be refunded (less \$6.00) with written notice to the Trial Secretary and a letter from a Vet prior to the start of judging the first class.

A RECORDING FEE is required for each dog entered at any AKC Licensed or Member Club Show, Obedience Trial or Rally Trial. This Recording Fee is to be collected by the show giving club and paid to AKC. If a dog is entered in more than one class in the show, the Recording Fee is to be collected on ALL ENTRIES. (AKC Dog Show Rules, Chapter 11, Section 2.)

CONDITIONAL ENTRIES: No entry shall be made or an entry accepted which specifies any condition to its acceptance.

CHANGES, ADDITIONS, CORRECTIONS to entries and entry forms must be received in writing prior to close of entries.

OVERNIGHT & EXPRESS MAIL must have the signature requirement waived.
